The First Fruits is a payment to the King [formerly the Pope] of one years Benefice revenue of a Bishop upon his appointment.

Tenths is a payment to the King [formerly the Pope] of 10% of each years Benefice revenue.

Abstract of Deed relating to the lands settled upon John Pretyman [son of Sir John Pretyman] and Margaret his wife and the jointure derived from the lands being the Manor of Horninghold, the Mansion and Rectory of Loddington and lands in Battersey Kent.

Sir John Heath MP and Dame Margaret, alleging that Dame Margaret has been defrauded of her jointure by Sir John Pretyman MP and Sir George Pretyman Baronet. They request that the Manor of Horninghold should be settled on Dame Margaret and her heirs and assignees.

John Atkins of Stanwick [Northants] executor of John Atkins his father deceased. Whereas in Michaelmas [29th September] 1663 a parol lease was made by Richard Verney on behalf of Dame Mary Pretyman with Nicholas Atkins for John Atkins his father of the mansion house and homestead with gardens and orchards and also two closes called Palmers Close and Dane Court Close, each about 4 acres to hold from Michaelmas from year to year at a rent of £22 per annum and whereas the said John Atkins the elder died a few weeks before Ladyday [25th March] 1667 leaving his wife in possession who soon after put an under-tenant in, and whereas only part of the rent was paid, Sir John Heath MP and Dame Margaret have made an agreement with John Atkins for rent payable.
